Date: Saturday, October 30, 2010

Location: Franco's Athletic Club

100 Bon Temps Roulé Mandeville, La 70471

Directions: From N.O. take Lake Pontchartrain Causeway Boulevard to Highway 22 and go west for 2.4 miles to

Franco's on south side of road at a stop light. From Slidell or Baton Rouge take I-12 to Hwy 21 (Exit 59) or Hwy 1077 (Exit 57), respectively, about 3.5 miles south to Madisonville and go east across

bridge on Hwy 22 for another 1.8 miles to Franco's.

Course: Outdoor heated pool, 25 yards, 8 competition lanes. A separate 6-lane pool (4 lanes only) warm-up

pool will be available at all times.

Time: Saturday, October 30, 2010. Warm-ups 10 AM. Meet starts at 11 AM.

Rules: USMS rules will govern this meet. All events will be timed finals, and will be seeded slow to fast,

except for "mystery" events. This is not a sanctioned meet. The pool is not quite 25 yards long so not eligible for Top Ten or SMS records. With the exception of current members of Franco's Athletic Club, swim meet participants must be current members of U.S. Masters Swimming (USMS) and provide proof of membership by providing a copy of participant's current USMS registration card with this swim meet application. Swimmers who are members of Franco's Athletic Club need <u>not</u> be

members of USMS nor Franco's Fit/Masters Swimming Team in order to participate in this swimming

meet.

Entries: Entries MUST BE POSTMARKED NO LATER THAN Monday, October 25, 2010.

Entry fee is \$15, includes Spooktakular Lunch Special: Cajun Dog, potato salad, and drink (beer

or soft drink). Late and deck entries will be charged \$20.

Check-In: All swimmers must check in by 10:00 AM. so that heat sheets can be prepared.

Age Groups: 18-24, 25-29, 30-34, 35-39, etc.

Scoring: Points will not be totaled since this is a developmental meet to encourage new competitive swimmers

and give other Master Swimmers an additional chance to compete at a reasonable price. Medals will

be given only to first-time competitors.

Limit of Events: Five (5) individual events and three (3) "mystery" events
